S.R.O. 124.— In exercise of the powers conferred by section 60 of the Cantonments Act, 1924 (2 of 1924), and in supersession of the notification of the Government of India in the Ministry of Defence No. S.R.O. 414, dated the 14th November, 1957, the Cantonment Board, Badamibagh, after having complied with the provisions of sections 61 and 62 of the said Act, and with the previous sanction of the Central Government, hereby imposes a tax on all persons exercising within the limits of the Badamibagh Cantonment Board a profession, trade or calling, enumerated in the Schedule hitherto annexed at the rate shown against each.
