# DRAFT BADAMIBAGH CANTONMENT BOARD REGISTRATION AND CONTROL OF PET DOGS BYE-LAWS 2024

(To be framed/ notified by the Badamibagh Cantonment Board under sections 348 and 350 of the Cantonments Act 2006)

### Badamibagh Cantonment Board (Registration and control of Pet Dogs) Bye-Laws, 2024"

- **1. Short title and commencement**: (i) These Bye-Laws may be called the Badamibagh Cantonment (Registration and Control of Pet Dogs) Bye-laws, 2024.
- (ii). These bye-laws shall be applicable within the limits of Badamibagh Cantonment.
- (iii) They shall come into force from the date of its publication in the official Gazette.
- **2. Definitions:** In these Bye-laws, unless the context otherwise requires:-
  - (a) "Act" means the Cantonment Act, 2006.
  - (b) "Board" means the Cantonment Board, Badamibagh as defined under Section 2(b) of Cantonment Act, 2006 (41 of 2006).
  - (c) "Chief Executive Officer" means the Chief Executive Officer of the Cantonment Board, Badamibagh.
  - (d) "Section" means a section of the Cantonment Act, 2006.
  - (e) "Owner" means the owner of a dog and includes any other person who has the custody of such a dog, with or without the consent of its owner.
  - (f) "Dog" means Pet dogs, other than stray dogs.
  - (g) All expressions used herein, but not defined shall have the meaning as assigned under the Act.

### 3. Procedure for Registration of Dogs:

- (a) The owner of any dog who keeps or brings any dog within the limits of Badamibagh Cantonment, shall register such dog at the office of the Cantonment Board within seven days of its arrival. Such registration shall be effectuated upon the payment of a one-time registration fee of Rs. 500/- or any revised registration fee. The Chief Executive officer or the Health Supervisor as authorized by him, may register such dogs.
- (b) Each owner whose dog or dogs are registered under the bye-law No. 3(a) shall be required to pay an annual license fee of Rs. 500/- or any revised annual license fee to Cantonment Board, Badamibagh, as and when notice to this effect is presented to him.

Provided that the above levy shall not apply to such dogs which are brought within the limits of Badamibagh Cantonment for less than 7 days.

Provided that the said dog has been properly vaccinated as per the medical standards prescribed by the Ministry of Health and Family Welfare.

- (c) The form for registration shall be provided on an application made to the Chief Executive Officer of the Cantonment Board to that effect.
- (d) That on receipt of form of registration, duly filled in, by the office of the Badamibagh Cantonment, the owner shall be supplied by the Cantonment Board a metal ticket for the collar to be put around the neck of the dog. The cost of the metal ticket, as determined by the Chief Executive Officer, shall be borne by the person applying for registration.
- (e) The owner shall ensure the vaccination of the dog prior to its registration.

### 4. Duties and responsibilities of the owners:

- (a) The owner of the pet dog shall be responsible for the controlled breeding, immunization, neutering and licensing in accordance with the provisions of these Bye-Laws.
- (b) Any dog not duly registered under these Bye Laws or not wearing a metal ticket, as prescribed, may be removed from any public place by an authorized functionary of the Cantonment Board and shall be liable to be dealt under the orders of the Chief Executive Officer, if not claimed within 7 days by the owner.
- (c) For the purpose of these bye-laws, any person in charge of the dog, during the absence of the real owner from the limits of Badamibagh Cantonment, shall be deemed to be the owner of the dog.
- (d) It shall be mandatory for each owner to carry disposable bags to collect any litter or defecation made by his dog while walking or resting on the roads or streets of Badamibagh.
- (e). No owner or person in charge of the dog shall allow such dog to defecate on any road/street/drain within the limits of Badamibagh Cantonment. In case any dog is found defecating on the road/street/ drain, it shall be the duty of the owner concerned to clean the excreta and pack it in a disposable bag, to be disposed of in the same manner as the human excreta is disposed of.

### 5. Guideline for dog breeders:

- (a) A dog breeder must be registered with Cantonment Board, Badamibagh. He must maintain a full record of the number of puppies born/died from individual bitches. He shall also maintain a record of pedigree and vaccination.
- (b) The dog breeder must maintain a record of the person buying or taking ownership of any puppy. He should ensure that such a person has the required knowledge for the upkeep of the puppies.

- (c) For the purpose of one-time registration charges and annual registration fee, the breeder shall have the same obligation as the dog owners under these bye-laws.
- 6. Whoever, being the owner or person in-charge of any dog, neglects to restrain it from roaming free or be at large in any street without being muzzled and without being secured by a chain, in any case in which—
- (a) the dog annoys or intimidates any person with or without the owner's knowledge, or
- (b) the Board has, by public notice during the prevalence of rabies or any such disease, so directed, shall be punishable with fine as determined by the Board.

### 7. Whoever in a cantonment—

- (a) allows any ferocious dog which belongs to him or is in charge of, to be at large without being muzzled; or
- (b) sets on or causes any dog or other animal to attack, worry or intimidate any person; or
- (c) knowing or having reason to believe that any dog belonging to him or in his charge has been bitten by any dog or animal suffering or reasonably suspected to be suffering from rabies, neglects to give immediate information of the fact to the Chief Executive Officer or gives information which is false, shall be punishable with fine as determined by the Board.

### 8. Penalty:

Any contravention of these Bye-Laws including the failure to register the dog as per Bye-Law No. 3 above, shall be punishable with a fine as determined by the Board from time to time, and in case of continuation of such contravention, the fine shall be determined based on the number of days of such continuous contravention.
